Above is a copy of the list of the children of SAMPSON STRICKLAND and his wife BYTHE, a part of his Revolutionary War pension claim file no. R-10264. He was a resident of Wake County, North Carolina, during the Revolutionary War, where he took the oath of allegiance on November 24, 1777. In 1780 he married his cousin BYTHE STRICKLAND in Wake County. He died May 16, 1839 at about 82 years of age, when a resident of Franklin County, NC, to which he had moved a few years before his death. His wife, BYTHE, died in Franklin County, date not given.

All of the above named children were living in Nash County, North Carolina in 1846, when son EATON STRICKLAND applied for a pension based on his father's alleged five month tour under Captain COLLARS and six month tour under Captain CARRINGTON, both in the North Carolina Militia. SAMPSON reportedly was at the Battle of Stono. The pension claim was not allowed, as proof of service as required by the pension law was not furnished.

A MARTHA STRICKLAND, age 76 in 1845, and then of Nash County, stated that she married into the STRICKLAND family, and that her husband was present at the marriage of SAMPSON and BYTHE.

Being Sound in mind And Memory (blessed be almighty God) I make and declare this my last Will and Testament in Matter and form as follows

1st I give and bequeath to Andrew STRICKLIN my Grey Filly also my two mules and Wagon with Harness. Also my Molasses Mill, One Bed, And Bed clothing for the Same.

I give to my beloved daughter Mary MILLIGAN all my clothing (except the Beds otherwise mentioned) to have and to hold during her natural life and at her death to go to Andrew STRICKLIN. Also I will to my daughter Rebecca PETTY my Cubboard and part of my Sh__[?-weak copy] Ware. Also I will to my Son Samuel STRICKLIN Five Dollars of the Money he is due me by Age, And the balance due me from him to be paid over to Andrew STRICKLIN for his use and benefit. Also I will to my Son Joseph STRICKLIN five dollars of the money _-[?] is due me which is twelve dollars and fifty cents. And the Balance after deducting five dollars to be Paid Andrew Stricklin for his use and Benefit. Further I will that all of my Hogs and Cattle be Sold at Private Sale except Such as Andrew STRICKLIN wants to keep for his own use. And out of the

Proceeds of Such as are Sold, my funeral expenses are to be Paid, the Balance of the Proceeds of Money to be Equally divided between my Brother Alexander RICHARDSON, Andrew STRICKLIN and my Daughter Mary MILLIGAN And the Balance of money Coming from the Estate of A.D. HARRISON deceased I will to Andrew STRICKLIN except that Portion that is going to Alexander RICHARDSON.

And lastly I appoint my Brother Alexander RICHARDSON and Andrew STRICKLIN my executors to this my last will and testament revoking all former wills by me made. In witness whereof I have here unto Set my hand and Affixed my Seal this the July the 16th 1880.

These two wills were contributed by Edwinna Stricklin. The script of the latter will is too faint to reproduce here. Several of the individuals named in the above wills appear in the 1880 Hardin County census data that follows, including Emily STRICKLIN, her grandson ANDREW J., her brother Alex RICHARDSON, her daughter Mary MILLIGAN, her sons Samuel STRICKLIN and Joseph STRICKLIN. William A. STRICKLIN, husband of Eliza, is Joseph STRICKLIN's son.

"Dialph ware" mentioned in the older will is certainly "Delft Ware". Along with the counter-panes (quilts) and other bedding mentioned therein, perhaps the checked "Real" is also some kind of bedding, such as a full-sized coverlet, contrasted with a "sham", which at the time was sometimes a strip of fine cloth folded over to appear to be the edge of the bedsheet. Any other ideas as to what a "real" in this context may have been?

THE NORTH CAROLINA VOTER REGISTRATION ACT OF 1902

Contributed by Charlotte R. Carrere

In a referendum held on August 2, 1900, the North Carolina Constitution was amended by the addition of Article VI Section 4 (generally known as the grandfather clause) which was to become effective July 1, 1902 and which provided that no person entitled to vote as of January 1, 1867, or any time prior thereto, and no lineal descendant of any such person could be denied the right to register and vote in any state election by reason of his failure to possess the required education qualifications.

The books remained open for registration from 1902 until 1908, but of these lists the most important one by far is the 1902 list as this was generally older men who were qualifying while the later lists were generally men who had just become old enough to vote.

The column headings on the records are as follows:

- (1) Name of person registering
- (2) Age of person registering
- (3) Name of person from whom descended
- (4) State ancestor was qualified to vote in as of January 1, 1867
- (5) Date of registration

Since I have abstracted all Strickland's from the Wayne County, NC list, I have added a 6th column...the township in which they lived. When column 3 is blank, this means the person registering was a qualified voter in his own right in 1867 or prior thereto.

[Editor's Note: Though I do not usually answer queries within the quarterly, I believe the above might be clarified by adding a little information from our files. MALINDA or MELINDA STRICKLAND was the daughter of Solomon Strickland (File #66) of Madison Co., GA. Solomon, son of Barnabas & Mrs. Rachel Mackie Brixley Strickland, was born 6 May 1790 in GA. He died 9 February 1854 and is buried in his family cemetery on the west side of US Hwy 29 north of Danielsville, GA. Strickland and his son-in-law, William White were named as executors of his estate. Malinda Strickland married William A. White on 17 August 1843 in Madison County, GA. -NJC]
